How to Cite St. Louis and Missouri Sources

Finding the correct source for information about your ancestor can require time-consuming research. Once you've found a record, book, person, Web page, artifact, or any source, make sure you document where you found it. You may need to return to that same record at some point and finding it a second time may be just as difficult as it was the first time. It can be frustrating to determine exactly what information needs to be included for a specific citation and what order the elements of the citation should follow. The society created this Web page to assist with citing St. Louis and Missouri sources. If you don't have St. Louis ancestors, these citations can serve as a model for any community. Just substitute your particular location utilizing the same format.

One of the biggest mistakes made by beginning genealogists is not thoroughly documenting where they find every piece of information. Most genealogists will admit they have a piece of information, found early in their research, for which they have no documentation. Don't make this same mistake yourself. Take some time to read and become familiar with *Evidence Explained; Citing History Sources from Artifacts to Cyberspace* or *Evidence! Citation & Analysis for the Family Historian* both by Elizabeth Shown Mills.

Citing an online database like *Ancestry.com*, *familysearch.org*, or *Fold3.com* with just the title of the Web page is not a sufficient source citation. Online genealogy sites usually have multiple databases, therefore the specific database title, date accessed, URL, and specific data found are all part of the citation. Several QuickSheets, based on *Evidence Explained* are available to assist with these source citations. These include <u>QuickSheet: Citing Ancestry.com Databases & Images</u>, <u>QuickSheet - Citing Online Historical Resources</u> and <u>QuickSheet, Citing Online African-American Historical Resources</u>.

As you read Web pages, check for citation guides on each site to help you understand all of the details of a source. For example, both the National Archives and Missouri State Archives have citation guides available online. The National Archives guide is "Citing Records in the National Archives of the United States: General Information Leaflet, Number 17," <u>http://www.archives.gov/publications/general-info-leaflets/17-citing-records.html</u> and the Missouri State Archives guide is "Research Room: Citing Records at the Missouri State Archives," <u>http://www.sos.mo.gov/archives/resources/citations.asp</u>.

At a minimum, for each piece of information in your research, you should document:

- the title of the source;
- the author(s), editor(s), or compiler(s);
- the publisher including date and place of publication;
- the page number;
- the film number;

- the series title;
- the record group name and number;
- the URL for any online source;
- the date found; and
- the repository where the source was located.

The best source is an original source, one created at the time an event occurred. A source is either original or derivative. The information a source provides is either primary or secondary information. The information needs to be analyzed as direct or indirect evidence to determine if it provides proof of the event. A birth certificate is an original source of information for the birth. An amended or delayed birth certificate is not an original source, but the information may be primary depending on who gave the information. The researcher must evaluate a source to determine who gave the information and the time frame in which it was given.

A death certificate is an original source for the death of that person. The birth information on a death certificate is secondary or tertiary information, depending on who gave the information. An index can be a source and direct you to a volume and/or page in a source, but the index should not be the only source you utilize. You should always consult the original record for the best source of information.

This Web page is designed to assist the researcher in citing St. Louis and Missouri records. As new St. Louis or Missouri sources are identified, additions will be made. - type of source;
- name of the source;
- author(s), editor(s) or compiler(s);
- publisher, publisher location, publication date;
- Web page title and URL;
- any other significant information about the source; and
- an example of the source with an actual citation to be used on the Web page.

Cemetery Records

Any cemetery index in printed or database format does not present original data. The data has been transcribed, edited, and reformatted. Some errors may occur along the way. In every case, the researcher is advised to use an Index to locate the cemetery and then to contact that cemetery for further information or actually go to the cemetery to look at the record or tombstone yourself.

Elements of the citation could include: Title, author or compiler, publisher, publisher address, date of publication, page number, name of person in record, URL, name of Web page, film or fiche number.

Census Records

Any census index or transcription in printed or database format does not present original data. The data has been transcribed, edited, and re-formatted. Some errors may occur along the way. In every case, the researcher is advised to use an index to locate the actual census entry and then read the census record yourself. Census citations can have a primary focus on the census year and type or on the person being researched. Either is acceptable. See the 1850 census for an example of both citations.

Elements of the citation could include: state, county, city or town, township, ward, year, type of census, enumeration district, printed page number, handwritten page number, dwelling number, family number, name of person, name of agency that created the microfilm, micropublication, roll number, Web page title, URL, title of record, any identifying information.

Court Records

Court records provide a vast array of genealogical information. Records include vital records for birth, marriage and death, coroners' records, probate records including guardianships, wills and administrations, land transactions, tax records, naturalizations, and divorces. For the most part, court records are created at the time the event occurs. Courts also heard civil and criminal matters. Court records may be found on the municipal, county, state, and federal levels. These records will need to be evaluated to determine who provided the information and their relationship to the principal in the record. An additional consideration is the provenance of the record. Was the record book copied more than one time? Were errors made when the record was read and recopied?

Land records, naturalization records, probate records, and vital records are included in their own sections of this chart.

Elements of the citation could include: the name of the court, the location of the court, the type of record, the name of the office creating or holding the record, the names of the participants, the date of the record, the case name, the volume and page(s) of the record, the Web page title, the URL, the date the record was accessed, the microfilm or microfiche number and item number, the repository for the film, and repository address.

Funeral Home Records

Funeral Home records are business records. Usually a family member provides the information to the funeral home employee during a period of grief. There may be errors due to the time the information is being collected or human errors transcribing the information from notes to the record. Take note of the informant to determine the validity of the information.

Elements of the citation could include: the name and address of the funeral home, the name of the record, book and page number, if applicable, the name of the deceased, the name of the person providing the information, the present location of the record, and the format of the record. If viewed on microfilm, include the repository and microfilm number.

Home and Personal Records

Many families have artifacts or family treasures that are passed down through generations. These may include family Bibles, baby books, land deeds, naturalization certificates, school and church certificates, samplers, quilts, family letters, diaries, or even family manuscripts. Where the court may have a stub for the naturalization, the family may have the actual naturalization certificate that was attached to the stub. The church may have provided a certificate of baptism to the family at the time of the event. These sources should be documented as personal artifacts. It is important to try to learn as much about the provenance of the item as possible to document its authenticity.

Elements of the citation could include: the type of record, the name and address of the person currently holding the record and how it was passed to them from the original owner, the condition of the record, the creator of the record, date of creation, any identifying information about the item, and comments about the source.

Hospital Records

Hospital records are business records. These are created at the time and any information about that hospitalization should be considered primary. However, any information about the patient's medical history should be evaluated to determine if it was provided by the patient or someone else in the family, a friend, or even an ambulance driver.

Elements of the citation could include: name of the name of the patient, information about the patient, hospital, city, state, repository, repository address, film number, and date accessed.

Land Records

Land records were created to determine who owned the land. Deeds, conveyances, mortgages, and liens were recorded at the local county courthouse. In some instances, land records may have been the only records saved during a courthouse fire or during the Civil War due to their importance. The Recorder's Office clerk transcribed the deed from the original into the deed book, giving an opportunity for transcription error. Some deed books have been recopied more than one time and each recopy provides an opportunity for transcription error again. Try to read the most original form of the records available.

Elements of the citation could include: the name of the city where the courthouse is located, the name of the county, the state, the name of office where land was recorded at the courthouse, the book number, the page number, the names of the grantor and the grantee, the date of the transaction, the date the transaction was filed, the Web page title, the URL, the author or compiler, the book title, publisher, publication location, date published, the creator of the microfilm with location, and the microfilm number.

Military records were created for enlistment, service, discharge, and pension. Military records are available on the federal, state, and local county level. Many military records have been microfilmed or are available on the Internet.

Elements of the citation could include: the name of the person serving in the military, rank, military unit, name of the war, National Archives catalog title, record group number, repository, repository location, agency that created the record, and type of document.

Naturalization Records

Our ancestors did not just want to immigrate to the United States. They wanted the right to vote and hold office. They wanted to become naturalized and be citizens of the United States. In most instances, that required declaring their intention to become a citizen, filing a petition to become naturalized, and obtaining a court order finalizing the naturalization. At one point in history, an immigrant could go to the courthouse immediately after they stepped off the ship and file their intention to become a citizen. However, many waited until they reached their destination to file. Then they waited a certain number of years, based on the current laws, to file their petition to become naturalized. Until 1906, naturalizations were under the jurisdiction of any local court in the county of residence. For the most part, after 1906, naturalizations came under the jurisdiction of the federal government. Naturalization files obtained from NARA may contain the certificate of arrival that provides the date and name of ship for immigration.

Elements of the citation could include: name of the person being naturalized, year, file number, name of the court, location of the court, volume, page, city, state, record group title, record group number, record repository, repository location, film creator, and film number.

Newspaper Records

Newspapers provide a picture of the day to day lives of our ancestors and the areas where they lived. Look for obituaries, lists of burial permits, births, and marriages. Articles may be found about ancestors who participated in government, social or sporting events, or received awards. Court cases and crimes were reported in the newspapers. Foreign language newspapers existed in St. Louis for several languages and many of the municipalities had their own newspapers.

Elements of the citation could include: the author of the article, the title of the newspaper, the title of the article, the date of publication, the page and column, the title of the Web page, and URL.

Probate Records

Probate records can include wills, administrations, probate packets, and guardianships. The will could have been created several years before it was actually presented to the court. Probate packets can include every receipt for expenditures at the time of death and until the probate process is completed. Inventories of all property owned by the deceased give a picture of the household.

Elements of the citation could include: name of the deceased, the type of record, the case name, the file number, the date filed and the date of the specific document being cited, the location of the probate case, the volume and page(s), microfilm number, Web page, URL, repository and repository address.

Religious Records

The religious house of worship was a place to record baptism, marriage, and burial records. Some baptism records include the date of birth and some burial records include the date of death. Each religion kept a different set of information for their religious practice. Some religions kept records in languages other than English.

Elements of the citation could include: name, date of the sacrament, name of the house of worship, town, county, name of the series, volume and page(s), repository, microfilm number, item number, Web page, URL, author or creator.

Vital Records

The city, county, or state may keep records of the births, marriages, divorces, and deaths of the people and these are considered the vital records of the community. The information on a local version of a vital record may not be the same on the state version. Indexes may or may not exist for vital records. The researcher is encouraged to search the records when an index does not reveal an ancestor; a recorder's spelling of a name or an indexer's interpretation of a name may hide an ancestor who is actually in the record.

Elements of the citation could include: the name(s) of the person(s), date filed, title of the record, type of record, date of record, the number of the record or certificate, the agency creating the record, the city and State of the agency creating the record, Web page title, URL, series title, page number, and volume number. If a record is written in a foreign language, make note of that also.
